

CAREER OPPORTUNITIES IN HUMANITARIAN ACTION AND RELIEF

Description of the Field:

We currently face a growing number of disasters and emergencies around the world and unprecedented levels of humanitarian need exacerbated by dozens of highly violent, protracted conflicts, the COVID-19 pandemic, and climate change. From flash flooding and forest fires that spread devastation rapidly, to protracted conflicts that cause migration flows, mass human suffering, and economic disaster, humanitarian need is on the rise worldwide. The purpose of humanitarian action is to save lives, preserve human dignity and minimize suffering resulting from conflict, natural phenomena, and epidemics. Humanitarian action is centered on basic and immediate human needs and is thus distinct from, though inextricably linked to, development, peace, and state building, which operate in a longer time horizon. These problems frequently overlap, particularly in the low-income countries in Africa, Asia, and Latin America. When combined with weak political, economic and social systems, low levels of resilience and state capacity, and/or civil war, humanitarian disasters become even more difficult to solve.

Humanitarian relief is an extraordinarily complex subject involving many actors, including governments, non-governmental organizations (NGOs) and intergovernmental organizations (IGOs), such as United Nations agencies, which seek to respond simultaneously to natural disasters (e.g. earthquakes and hurricanes) and/or complex emergencies (e.g. war and other violent conflicts). These actors employ life-saving skills and technologies to re-establish basic services, such as water and sanitation, set up schools, and to provide food and medical supplies.

Career Paths and Entry Salaries:

There are close to a million nonprofits, state and federal government agencies, and organizations locally and internationally that provide humanitarian assistance. As humanitarian relief is such a large field, it is difficult to provide a baseline salary, which varies based on the size and focus of the organization, the type of job within the organization, and the geographic location. Salaries can range from \$45,000 (entry-level in an NGO) to over \$125,000 a year for a senior level position.

Demand:

The environment where humanitarian action takes place is evolving rapidly and continually poses new challenges to the global community. The United Nations' (UN) Global Humanitarian Overview for 2021 predicts a record 235 million people will need humanitarian assistance and protection over the next year, an almost 40% increase over 2020 (UNOCHA). As needs and funding have risen, so too have the numbers of aid workers. Today, hundreds of thousands of people are employed in humanitarian aid. The estimated number of humanitarian workers has increased by 27% in the past three years (ALNAP 2018).

The last decade has seen a marked increase in the occurrence of natural disasters along with exposure to greater levels of loss of life, property and material damage. The lives of millions of civilians are at risk each time an earthquake, hurricane or other natural disaster occurs, particularly in low- and middle-income countries with fragile and underdeveloped infrastructures, high population densities and inadequate emergency preparedness (www.unocha.org). There is clearly a high demand for professionals to respond to such crises, and there are growing numbers of opportunities for administrators, fundraisers, grant-writers, program organizers, teachers, researchers, policy analysts, and others.

Recommended Qualifications to Enter the Field:

A Master's degree in International Affairs, International Development or a joint Master's of Public Health/MA degree, a dedication to making the world a better place to live, and a desire to serve others by doing good work are all necessary qualifications to enter this field. An expertise in one of the key technical areas including food security, public health, nutrition, logistics, or conflict resolution is strongly recommended to effectively and permanently solve issues that arise when disaster occurs. Candidates must also demonstrate business acumen, personal diplomacy and ability to work in challenging contexts under high stress. Other necessary qualifications for some positions include two or three years of experience in the developing world and the requisite foreign language requirement.
